2. Abnōnō ko kin kalijeklok rej aikuj lelok ñan Ritōl eo an Jikin eo ej Lelok Jibañ kin Õn, Opij eo an Ritōl eo an Jikuul in Kien, Ritōl eo an Jikin eo ej Lelok Jibañ kin Õn enaj lemaanlok ñan Opij eo ej Bōk Eddon Jibañ ko ikijen Mōñā im Õn ilo Opij eo an Bukon eo Ralik, San Francisco.
3. Abnōnō ko kin kalijeklok remaron lelok ilo jeje ak kenono. Ejab aikuj kōjerbal peba ñan an armij bael abnōnō. Ñe juon armij rejab kōnaan, jab mōñōnō, jab maron, ak jab lomnak in lelok abnōnō eo ilo jeje, armij eo ej kōmmáne abnōnō eo enaj kōmmáne mennin. (Emōj liküt Peba in Abnōnō.)
