## New Server and Backup Application

1. **Purpose:**

In accordance with RCW 43.105.375, OSPI was required to move its on-premises data center into the Washington Technology Solutions’ (WaTech) state data center (SDC). Doing so required new server hosts, storage array network, firewall and switches as existing technical infrastructure was past its replacement cycle. Additionally, a new backup and recovery solution was required as the agency’s then-current application was not compatible with the new technical infrastructure environment.

2. **Description of services provided:**

New server hosts, storage array network, firewall and switches installed, configured and put into production.

New application and data backup and recovery solution was installed, configured and put into production.

Without the continuation of funding, a less capable application and data backup and recovery alternative will be required to match the level of funding allocated.

Continued funding for the application and data backup and recovery application in the 21-23 biennium and forward.

11. **Statutory and/or budget language:**

Budget Proviso: \$46,000 of the general fund-state appropriation for fiscal year 2020 and \$46,000 of the general fund-state appropriation for fiscal year 2021 are provided solely for a new server and backup application due to the move to the state data center.
