### PURPOSE/BACKGROUND

The purpose of this bulletin is to advise school districts of the first addendum to the *Accounting Manual for Public School Districts in the State of Washington (Accounting Manual).* The effective date of the addendum is September 2020, and the changes are applicable to the school district fiscal year beginning September 1, 2020.

# Allowable Transportation-Related Services in the Remote Learning Environment

#### **Chapter 6–General Fund Expenditures**

On page 6-27, transportation related costs, permissible in the remote learning environment are described in the guidance for Program 99. The costs are an allowable use of the Revenue 4199 Transportation allocation.

Transportation-related services as necessary to provide students with the opportunity to equitably access educational services in a remote learning environment are considered permissible transportation activities and deemed an allowable use of the current transportation allocation.

#### Those services include:

- The use of bus drivers, and the corresponding use of school buses, to deliver one or more of the following education tools and services to students in their remote learning locations on a schedule to be determined by school districts:
  - learning materials, including but not limited to workbooks, homework packets, paper assignments, and other tangible instructional materials;
  - o meals; and
  - o any hardware, WiFi hotspots, or other technology solutions that increase student access to remote learning online curriculum; and
- The transportation of students to and from learning centers or other public or private agencies where educational and support services are provided to students.

School districts are required to track and document the specific time and uses of school buses and bus drivers to deliver the above services.

On page 6-40, a new Activity code is added to the Chart of Accounts. Activity 58 Remote Learning Operations is provided to account for the operation of buses and drivers in the remote learning environment.

#### **58 Remote Learning Operations**

Include direct operating expenditures for buses used in the remote learning operations. The only salaries charged to this activity are those of the bus drivers.

Also include contracted service payments to firms for the direct costs incurred for operating buses in remote learning operations. Other portions of payments made to contracted firms for transportation-related services should be allocated to other appropriate activities within Program 99: Supervision, Maintenance, and Insurance.

Include other transportation expenditures for remote learning operations carried out by means other than school buses.

Vehicle fuel costs should be charged to Object 5 under this activity.

#### **APPENDIX B**

On page B-4, under the section titled Miscellaneous Issues, a new topic titled *Transportation* and *Remote Learning* is added to the guidance which describes the accounting treatment of costs incurred in Program 99 deemed allowable in the remote learning environment.

#### **Transportation and Remote Learning**

No provisions of RCW 28A.160 (Student Transportation), may be interpreted or applied to restrict a school district's ability to use its current transportation allocations to support the transportation-related services as necessary to provide students with the opportunity to equitably access educational services in a remote learning environment. The prohibition, to interpret or apply guidance that may contradict this section, extends into the School District Accounting Manual.

Transportation-related services deemed an allowable use of the current transportation allocation include:

• The use of bus drivers, and the corresponding use of school buses, to deliver one or more of the following education tools and services to students in their remote learning locations on a schedule to be determined by school districts:

- learning materials, including but not limited to workbooks, homework packets, paper assignments, and other tangible instructional materials;
- o meals; and
- o any hardware, WiFi hotspots, or other technology solutions that increase student access to remote learning online curriculum; and
- The transportation of students to and from learning centers or other public or private agencies where educational and support services are provided to students.

School districts are required to track and document the specific time and uses of school buses and bus drivers to deliver the above services. School districts will be required to account for bus miles provided for Remote Learning Operations on the annual School Bus Mileage Report, provided to OSPI. "Remote Learning trips" should be tracked for informational purposes only. The costs will remain in Program 99. Remote Learning trips should be tracked in a similar fashion to how bus usage is tracked for the typical non-to-and-from pupil transportation services, such as extracurricular activities or field trips.
