Dear Assistant Secretary Delisle:

Washington's Office of Superintendent of Public Instruction (OSPI) is requesting a one-year waiver of the Title I, Part A regulatory provision that prohibits a state from approving as providers of supplemental educational services (SES) schools identified for improvement, corrective action, or restructuring, and local educational agencies (LEAs) identified for improvement or corrective action (34 C.F.R. § 200.47(b)(1)(iv)(A),(B)).

Under the law, OSPI may approve as an SES provider only an entity that has a demonstrated record of effectiveness in increasing student academic achievement. Washington believes that identified schools and LEAs may be able to establish that they have an effective program that can help improve academic achievement of students and should not be prevented automatically from gaining approval simply because of their improvement status.

Washington is in the process of reinstating the attached elementary, middle, and high school state uniform bar goals in reading and mathematics for 2014. See Attachment A. This is a result of Washington's loss of the state's ESEA Flexibility Request (Waiver). Reading/language arts and mathematics are among those content areas that will be covered by SES providers in Washington for the 2014–15 school year.

Washington will determine adequate yearly progress (AYP) based on assessments administered in the 2013–14 school year in accordance with the requirements of section III(b)(2) of the Elementary and Secondary Education Act of 1965 (ESEA).

Washington believes that, ultimately, allowing some identified schools or LEAs to serve as SES providers will help more students within Washington to reach the state's proficiency objectives. If granted the requested waiver, Washington will ensure that only those LEAs and schools that meet the state's requirements for SES providers are approved to be on the state's list of approved SES providers for the 2014–15 school year.

Prior to submitting this waiver request, Washington provided all LEAs in the state, and the public, with notice and a reasonable opportunity to comment on this request. In summary, OSPI assures that, if granted the requested waiver, the agency will submit to the U.S. Department of Education, by September 30, 2014, a report that provides the total number of LEAs identified for improvement or corrective action that were approved to be an SES provider for the 2014–15 school year and the total number of schools identified for improvement, corrective action, or restructuring that were approved to be an SES provider for the 2014–15 school year.

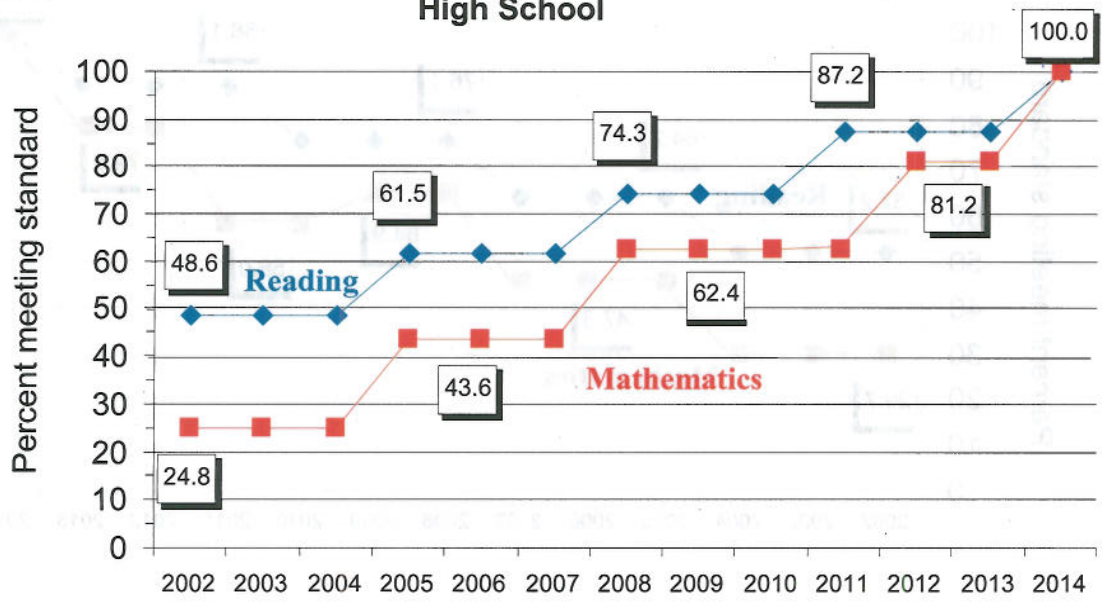

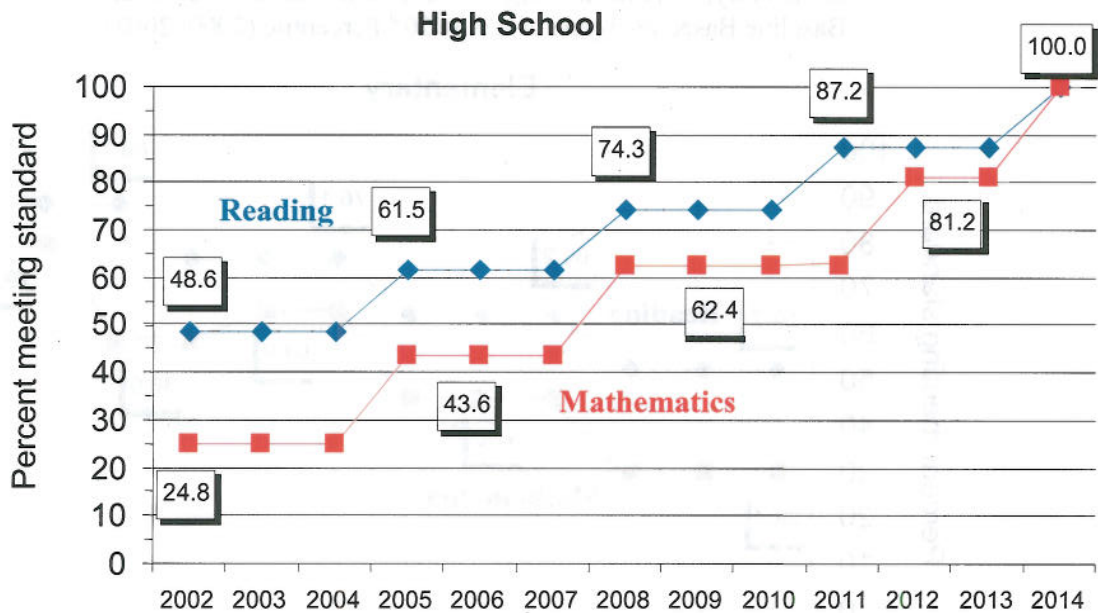
Elementary, Middle, and High School State Uniform Bar Goals

SES is not an effective support to struggling students in Title I schools (see the Inspector General's report). Our teachers struggled with the time commitment and documentation required when we did act as a provider 4 years ago. Additionally, if we are a provider I have to spend funds to hire staff to monitor the activity outside the current work in Title I. I do not want to spend any part of the 20% set-aside on central staffing. I would prefer to let the vendors apply, and after the second window, release the funds to support students during the school day.

Applying for a waiver would in now way help my students and provide them the support they need during the instructional day.
