Na fa i a pumtlinlonak umtuning, nan chungkhar chungtel pawl i miphun le miphun sinak, le na siangngakchia i nulepa sinak aa fianternak kong kha nangmah lungtho tein na kan chimh ahcun, mah na chimhmi kong cu a thlithup in kan chiah lai i kan pine chung i a tlangpi in thil umtuning fianter ding lawngah hman a si. Washington sianginn pawl caah kan lamhmuhsaknak pehzulh in thanchoter ding le siangngakchia pawl le chungkhar pawl covo a bawmmi kan tuahtu ning pawl thanchoter dingah, pumpak siangngakchia asilole chungkhar sin ah pehtlaih ter lonak he, hi thawngthanmi cu a dihlak in kan hman.
